Welcome by the Chairman

Stephen opened the AGM at 7pm and welcomed the committee and the public.

Minutes

The minutes of the last meeting held on 15th January 2025 were signed as a true record of proceedings.

Annual Reports

Treasurer's Report

Glenn presented the details of the treasurer's report.

The statement of accounts (which are unaudited) were presented for the financial year ended 31st December 2024, these have been independently verified by Helen Anderson.

The hall retains a healthy bank balance of £46888.10 as at 31st December 2024. Most of the income for 2024 was "Buy A Brick" scheme, Bingo evening and the sponsored bike ride by Glenn Ford & Carl Stretton.

A copy of the detailed report is attached at the end of these minutes.

Chair's Annual Report

Stephen read out the Chair and Committee report and a brief summary is as follows:

A number of events took place and all had been successful albeit not always profitable. Bingo night, Quiz night, Santa's grotto and The Final Shindig were all very well supported, we are confident that we sent the hall off in style at the "Final Shindig" event where we had approximately 80 people attend.

We have been successful in securing a number of grants together with donations for the rebuild project of approximately £300K in addition to our fundraising at events and buy a brick scheme.

There were no matters arising from the previous meeting or what has been discussed so far at the AGM.

Update & Progress on new build

We have now received the structural report for the groundworks and foundations and works should start around mid July. The contractors are waiting for their first payment and the timber frame now has an eta start date of end July or beginning August. This is currently being built off site so when delivered it will be erected pretty quickly.

Deeds for the Cil & Lottery Funding

The Lottery funding requires "Deeds" which is a legal document mainly for the resale purposes in the future. Also if trustees change the Deed remains with the hall and transfers to the new trustees. Michaela has kindly done all the legal work on our behalf and the "Deed" has been exchanged and we are now able to draw down the funds from the lottery for the rebuild project.

We are doing a similar Deed for Hunts District Council for the CIL funding they granted to us.

For the Cambridge Capital fund they only require Teams meetings once a month to update them directly on the progress.

We would like to take this opportunity to thank Michaela for all her hard work and time in sorting all this out for us.

Approval of Estimated Project Costs

The estimated project costs are still £400-£450K

With all fundraising, pledges and buy a brick scheme we have around £361K

SS & NP are constantly looking for new funds & grants and applying for them when applicable.

We have already paid for the demolition, reporting by various authorities, architects, planning, structurals and paid a £10k deposit on the timber frame building.

Buy A Brick Update

This has been a big success and has raised almost £6K so far with more people saying they would like to buy one but have not done so as yet.

Strawberry Afternoon Tea

Date has been set for the 21st June between 2-5pm.

LS to make up posters for the green and flyers to be put through doors. EH & family are hosting this event at their home farm and will liaise via whatsapp and email nearer the time regarding finer arrangements.

Stephen closed the meeting and requested that all current committee members stand down.

REBUILD PROJECT UPDATE

THE BUILDING WAS DEMOLISHED AND THE SITE CLEARED IN MARCH 2025—this was required as a condition of one of the funding awards (funds needed to be drawn down before the end of the financial year)

THE ABILITY TO FUND THE PROJECT IS CHALLENGING AND WE ARE CONTINUING TO PURSUE EVERY OPPORTUNITY.

WE HAVE SECURED FUNDS FROM GLATTON PARISH COUNCIL – WE WOULD LIKE TO THANK CARL STRETTON AND ALL OF THE COUNCILORS FOR THEIR SUPPORT.

WE WERE ALSO SUCCESSFUL IN SECURING A COMMITMENT TO FUNDING FROM HDC IN THE FORM OF CIL FUNDS £49750 – THANKS TO ROW LYONS AND HER TEAM AND ALSO COUNCILOR SIMON BYWATER FOR HIS GUIDANCE AND SUPPORT.

WE HAVE BEEN AWARDED A GRANT OF £40,000 FROM CAMBRIDGE CITY COUNCIL PRIORITIES CAPITAL FUND – THANKS TO ANNA BRADLEY-DORMAN FOR HER GUIDANCE AND SUPPORT.

WE HAVE SECURED A FUNDING COMMITMENT FROM THE BERNARD SUNLEY FOUNDATION OF £10,000 FOR WHICH WE EXTEND OUR GRATITUDE.

WE HAVE SECURED A FUNDING COMMITMENT OF £200,000 FROM THE NATIONAL LOTTERY COMMUNITIES' CAPITAL FUND – WE WOULD LIKE TO THANK TIA HALLIDAY AND HER TEAM WHO HAVE BEEN VERY SUPPORTIVE OF OUR PROJECT.

WE CONTINUE TO RECEIVE GOOD SUPPORT FOR OUR "BUY A BRICK "CAMPAIGN

WE WOULD LIKE TO THANK CARL STRETTON AND GLENN FORD FOR THEIR FUNDRAISING EFFORTS FROM THE BIKE RIDE ACROSS THE NORMANDY BEACHES SUPPORTING THE D DAY COMMEMORATION EVENTS.

WE ARE NOW REGISTERED FOR GIFT AID WHICH ALLOWS US TO CLAIM BACK APPROX 25% ON ALL FUTURE ELIGIBLE DONATIONS.

WE HAVE DECIDED THAT WE HAVE SUFFICIENT FUNDING PLEDGES IN PLACE TO START THE PROJECT AND ARE CONFIDENT THAT WE WILL SECURE ADDITIONAL FUNDING NEEDED TO COMPLETE THE PROJECT.

WE BELIEVE THAT THE PROJECT WILL COST IN THE REGION OF £400,00 TO £450,000

THE BUILD.

WE HAVE APPOINTED A MAIN CONTRACTOR FOR THIS PROJECT AFTER RECEIVING THREE QUOTES.

CARLSON BUILD ARE LOCAL CONTRACTORS WHO SUPPLIED THE MOST COMPETETIVE QUOTE AND ACCEPTABLE REFERENCES, WE LOOK FORWARD TO WORKING WITH THEIR TEAM TO DELIVER THIS PROJECT.

WE ARE ADVISED THAT THE STRUCTURAL ENGINEERS HAVE COMPLETED THEIR SURVEYS AND HAVE ISSUED RECOMMENDATIONS REGARDING GROUNDWORKS AND TIMBER FRAME LOAD BEARING REQUIREMENTS.

WE EXPECT THE SECOND PHASE OF WORKS TO COMMENCE IN THE NEXT FEW WEEKS.

WE WILL KEEP THE VILLAGE HALL WEBSITE UPDATED WITH PROGRESS REPORTS
